

ELIGIBILITY CRITERIA

- 1. The firm should submit attested copies of GST Registration/PAN/TAN No.
- 2. The Manufactures/ Authorized suppliers should not have been blacklisted by any Govt., SemiGovt. Department., or any other organization.
- 3. If the Manufacturers are not in a position to quote, they may authorize suppliers. The suppliers should submit a valid Certificate from their Principals to the effect that they are the authorized agents of the Manufacturers and that they are authorized to supply the items.

TERMS AND CONDITIONS.

- The Tenders should be sealed and superscribed 'Supply of CHEMICALS, GLASSWARES
 AND LABWARES', along with Notice No. and due date, and addressed to the Registrar,
 M.G.University.
- 2. Tenders from Manufacturers / Authorized Suppliers will be accepted. Tenders from authorized suppliers who fail to attach a valid **Authorization certificate** from their Manufacturers along with the Tender, will be rejected.
- 3. **Catalogue/Price List (Hard Copy)** should be submitted along with Tenders. Offers received without Catalogue/Price List will not be considered.
- 4. The manufacturer shall ensure that the products will not be sold to any other clients at rates cheaper than the price offered to M.G.University, FALL CLAUSE CERTIFICATE should be attached in this regard along with the Tenders. This letter should be on the letter head of the firm and should be signed by a competent authority.
- 5. An undertaking to the effect that the firm has **NOT BEEN BLACKLISTED** / **DEBARRED** should be attached with the Tenders.
- 6. Discounts offered shall be indicated clearly in terms of percentage.
- 7. Providing GST Registration/PAN/TAN No. details is mandatory, failing which the Tenders will be rejected. All future correspondences including Invoices should bear the GST Number.
- 8. M.G.University will not entertain any correspondence or queries on the status of the offers received against this Notice.
- 9. A Committee comprising of Heads of Science Departments headed by the Registrar, M.G.University reserves the right to accept/ reject/ partly accept any or all the Tenders received, without assigning any reason.
- 10. Non delivery of items within the time agreed upon, will lead to cancellation of Purchase Order without prior notice. In addition, action may be taken for removing such firms from the Rate Contract List.
- **11**. Replacement : Damaged / Broken / Inferior quality articles should be replaced by proper ones.

- 12. No Advance Payment / Part Payment will be made.
- **13**. M.G.University is registered under **Department of Scientific and Industrial Research** and hence eligible for availing concessional GST rate of 5% in terms of Ministry of Finance notification No: 45/2017-Central Tax & No. 47/2017 Integrated Tax Rate.
- **14**. The rate contract can be terminated at any time by giving one month's notice from either side.
