### **ORDER**

The Centralised Allotment Process for Post Graduate programmes to Arts & Science Colleges affiliated to the Universities in the State was implemented in the academic year 2010-11 and for Under Graduate Programmes, in the year 2011-12. Since then the Centralised Allotment process (CAP) have been running smoothly ensuring transparency, merit, reservation and rule based barrier free admission of students in the colleges affiliated to the Universities.

- 2. As per the Government Order read above and as envisaged under Section 73A of the Mahatma Gandhi University Act, 1985, a Committee was constituted for fixing the scale of pay and other conditions of service of the teaching and non teaching staff of unaided colleges and for determining the admission and selection of and the fees payable by students in such colleges. Based on the recommendations of the Committee, Government issued certain guidelines for regulating the admission and such other matters in the unaided Arts & Science colleges, vide the Government letter read as second above.
- 3. Now, the Vice Chancellor, Mahatma Gandhi University, vide letter read as 3rd above, has informed that the Hon'ble High Court in WP(C)No. 16431/2020 filed by the Self Financing Management Association have raised a doubt on the determination of the Government in implementing the recommendation of the Committee constituted vide the Government Order read above and requested to issue a Government Order expressing the determination of the Government in implementing the recommendations of the Committee.
- 4. Government have examined the matter and and are pleased to issue the following guidelines for conducting the Centralised Allotment Process (CAP) in all unaided Arts and Science Colleges affiliated to the Universities within the State.

#### FIIE NO.HE UN-B 4/224/2016-HE UN

- i. The admission to various Under Graduate & Post Graduate programmes conducted in all unaided Arts & Science Colleges affiliated to the Universities within the State shall be done through the single window system i.e, the Centralized Allotment Process.
- ii. The admission to all BEd training colleges affiliated to Universities shall also be conducted through CAP.
- iii. Universities shall conduct a minimum of 4 continuous allotments after which the number of supplementary allotments shall be decided by the Universities themselves. Colleges shall not be permitted to conduct spot allotments to merit seats after the completion of allotments. Universities shall implement their own mechanism to fill the vacant seats preferably through online allotments.
- iv. The application fee in respect of the CAP allotments shall be decided by the respective Universities.
- V. The details of the candidates admitted to Management Quota shall be uploaded by the respective college authorities to the Online Admission Portal on the date of admission itself.
- Vi. Any admission reported after the date of closing of admissions shall be considered irregular and under no circumstances such candidates shall be permitted to register with the University and appear for the examinations pertaining to the programme to which the candidate is reported to have been admitted irregularly.
- Vii. Universities should give adequate publicity in the matter.
