### **ORDER**

The new system of grace mark distribution for under graduate degree students from 2017 admission (CBCS 2017) onwards envisages distribution after the completion of the entire process of examination/revaluation/scrutiny. However this has resulted in a number of students not being able to obtain the benefit of distribution of grace marks although these students could obtain a pass at this point of time in spite of having pending results. This issue has been discussed in detail in a meeting in connection with Examination (Grace Marks) which was held on 8 September 2020 at 10.30 AM in the Office of the Pro Vice Chancellor and the following amendments/ additions to the existing provisions are recommended.

- 1. The candidate may opt for the distribution of grace marks irrespective of pending supplementary/revaluation/scrutiny.
- 2. If the candidate opts for such distribution, the grace marks shall be distributed considering the marks available at that point of time.
- 3. The grace marks so distributed shall be given to the best marks obtained by the candidate for a course as on the date of distribution.
- 4. Such distribution shall be permitted only if such distribution will enable the candidate to obtain a pass for the entire programme.
- 5. Any examination for which the candidate has registered and for which such distribution of grace marks results in an in-eligibility shall be cancelled.
- 6. If the candidate passes a regular exam on distribution of grace marks under this scheme, and is eligible (as per the regulation of the programme) for registration for the examination as an improvement candidate, such candidature shall not be cancelled. The status of such registration shall be changed from supplementary to improvement.
- 7. Grace mark distributed under this scheme shall not be carried forward to the improved marks if any obtained by the candidate upon publication of the results and shall be retained in the same examination where it was originally allotted.
- 8. The candidate shall be eligible to retain the best marks out of the two examinations for the purpose of consolidation.
- 9. If there is a change of marks on revaluation, the candidate shall be eligible for a change of original marks in the same manner in which a candidate without grace mark would have been eligible.

 Additional Grace Marks (Add on/ Top up) can be distributed in accordance with the U.O read 2 above, provided the Grace Marks already distributed shall not be displaced.

The Hon'ble Vice Chancellor exercising power u/s 3.10(17) of Mahatma Gandhi University Act 1985, has approved the above recommendations.

The U.Os read 1 & 2 above stands modified to this extent.
