In the prevailing situation of Covid-19 pandemic, the meeting of the Syndicate held on 26.08.2020, considering the recommendations of the University Research Committee (held on 24.08.2020) regarding the conduct of Pre-Ph.D. Presentations in the Statutory Departments/Approved Research Centres and forwarding of its reports to the Director of Research, resolved vide its minutes read as (3) above the following.

1. To authorize the Heads of the Approved Research Centre (Principal) to conduct the Pre-Ph.D. Presentation of their scholars in the centre itself, either in online or offline mode, by strictly complying with the modalities of the Pre-Ph.D. Presentation.
2. In Statutory Departments and in Approved Research Centres, if the Pre-Ph.D Presentation

is conducted through online video conference, to permit all the participants including the research scholar and the supervising teacher to attend the same online provided, the Pre-Ph.D Presentations conducted online shall be recorded and forwarded via e-mail to the Director of Research.

3. The report of the Pre-Ph.D Presentation shall be forwarded to the Director of Research by the Heads of the Statutory Departments and the Heads of the Approved Research Centres themselves, whether it is conducted online or offline.
