#### ORDER

The Principal, Al-Azhar Training College, Thodupuzha, had submitted application vide paper read as (1) above for starting an additional batch of 50 seats for B.Ed Programme during the Academic Year 2020-21.

The University considered the application and Inspection Commission was constituted for assessing the facilities available in the College vide paper (2) read above.

Since the application for starting the additional batch was received after the prescribed statutory date, it could not be considered by the University. The matter was referred to His Excellency the Hon'ble Chancellor of the University for consideration during the Academic Year 2020-21 vide paper (3) read above.

His Excellency the Hon'ble Chancellor, Vide paper (4) read above, has extended the period within which the Syndicate of the University shall consider the application for affiliation to the additional batch for B.Ed programme for the Academic Year 2020-21 up to 31st July 2020.

The report of the Inspection Commission was considered by the Syndicate of the University vide paper (5) read above, whereupon, it was resolved to accept the recommendations of the Commission and to grant affiliation to the additional batch of 50 seats, subject to the approval of the Government and NCTE

The permission to start the above programme is subject to the following conditions.

- 1. The provisional affiliation is granted initially for the Academic Year 2020-21 only.
- 2. The programme shall be conducted as per the approved schemes and syllabus.
- 3. The admission of the students and commencement of classes for the said programme in the College shall be in accordance with the rules and regulations of the University and NCTE.
- 4. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs.200/- to the effect that it will abide by the rules, regulations and instructions issued by the University, State Govt and NCTE regarding admission norms to the programme from time to time.
- 5. The institution shall observe the admission norms regarding the eligibility of candidates and the norms of reservation framed by the Government and the University.
- 6. The college has to remit an amount of Rs.31,500/- towards course affiliation fee
- 7. The Education Agency shall set apart 50% of the seats of the Course for being filled up by the Govt. or such authority determined by Government and the remaining 50% filled by the Educational Agency on the basis of merit.
- 8. The college shall submit the list of students admitted and remit the fees due to the University within 15 days after closing admission.
- 9. There shall not be any financial commitment to the Government/University.
- 10. Non-Compliance with any of the conditions would lead to the withdrawal of the affiliation.
