ORDER

Smt. Gangadevi T. R. was granted confirmation of part time registration for research in Economics under the guidance of Dr. K. Rajan at Sree Sankara College, Kalady, with effect from 01.01.2016, vide the U. O. cited (1). As her period of research expires on 31.12.2020, due to the reason that her research guide is coming under retired category, she has requested, vide the paper read as (2) above, for permission to extend the period of research for 6 more months as she could not complete her work due to Covid-19 Pandemic.

Having considered the matter, the Vice Chancellor, exercising powers of the Syndicate under Section 3. 10(17) of Mahatma Gandhi University Act 1985, has accorded sanction to extend the period of research of scholars who have been registered prior to 2016 Admission, irrespective of full time or part time and whose research period was limited due to being in the following category, upto 30.06.2021 or 5 years from the date of effect of registration, whichever is later:

- (i) Scholars doing research under the guidance of supervising teachers coming under retired/adjunct/deputed/transferred category.
- (ii) Scholars doing research in the centres:
 - (a) Coming under the jurisdiction of other Universities.
 - (b) Which have been wound up as per the U. O. s cited (3) and (4).
 - (c) Other than those which have been allowed, as mentioned at Serial No.4 of the U.O. cited (5).
