## NOTIFICATION

Sub: Mahatma Gandhi University- Election to the Senate U/S 17, Elected Members(4) of the MGU Act,1985- Filling up of vacancy – **Constituency : Teachers of Departments of the University.** – Notification of Election – reg.

(3) Statute 32 of Chapter 44 of the Mahatma Gandhi University Statutes 1997

Whereas it has become necessary to fill up of vacancies in the Senate of the Mahatma Gandhi University, reconstituted vide ref (1) under Section 18 (1) of the Mahatma Gandhi University Act, 1985, it is hereby notified as per Statute 32 of Chapter 44 of the Mahatma Gandhi University Statutes 1997, that election will be held to elect one member from the constituency of Teachers of Departments of the University, coming under section 17 – Elected Member, sub-section (4) of the Mahatma Gandhi University Act, 1985, in accordance with the system of proportional representation by means of single transferable vote.

Only persons whose names are on the electoral rolls of the respective constituency, already published, are eligible to take part in the elections and vote thereat, subject to the provisions contained in the Statutes. Every elector is at liberty to nominate one duly qualified person to the seat. Every Nomination Paper shall be proposed by an elector with his signature whose name is on the electoral roll and seconded by another elector with his signature. The candidate shall then sign a declaration on it, expressing his/her willingness to serve on the Senate, if elected. The candidate, the proposer and the seconder shall belong to the constituency of '**Teachers of Departments of the University**'.

Nominations shall be made in the prescribed form, which is available in the official website of the University wherefrom it can be downloaded.

Nomination Paper shall reach the undersigned not later than **2.00 p.m. on 22/01/2021**. The envelopes containing Nomination Paper should be superscribed "**Election to Senate – Nomination Paper – Constituency of Teachers of Departments of the University**"
