ORDER

The Bar Council of India has directed the University to maintain the intake of students as 60 per section in Three Year LL.B and Five Year LL.B courses conducted by Govt.Law College, Ernakulam and School of Indian Legal Thought, Kottayam (University Law Department) vide paper read as (1) above.

The matter was considered by the Syndicate of the University vide paper (2) read above and decided to direct the Colleges to maintain the maximum number of students as 60 in each section of the Law degree programmes.

The Government, vide paper (3) read above, has sanctioned an additional batch of 60 students for Three year LL.B course in Government Law College, Ernakulam for the Academic Year 2020-21. Besides this, the Government vide paper read as (4) above, has sanctioned 10 percent seats over and above the approved/ sanctioned strength of seats for Economically Weaker Section to Three Year LL.B and Five Year B.Com LL.B courses subject to the approval of Bar Council of India. The Bar Council of India has given approval in this regard, vide paper read as (5) above.

Therefore, the matter was reconsidered by the Syndicate of the University vide paper read as (6) above and decided to interpret the Syndicate decision on 13.10.2020 regarding intake of

maximum number of students in each section of Law degree programmes in Government Law College, Ernakulam, as (i) Three Year LL.B Programme - 60 seats Batch 1, (ii) Three Year LL.B Programme - 60 seats Batch-2, (iii) Five Year LL.B Programme - 60 seats and also resolved to implement the decision of the Bar Council of India regarding the EWS seats.

The number of seats for Three Year LL.B programme has been fixed as 132 (120+12), the number of seats for Five Year B.Com LL.B programme has been fixed as 66 (60+6) in the Government Law College, Ernakulam and the number of seats for Five Year BBA LL.B programme in the School of Indian Legal Thought, Kottayam, has been fixed as 60 for the Academic Year 2020-21.

Orders are issued accordingly.
