ORDER

As per the application read (1) Mr. Malik Zia-Ul- Hak, a Foreign National and also a student of BBA course of the University, from the Off Campus Centre Sharjah, requested to issue a Duplicate Marklist. As per the criteria for issuing duplicate certificates the candidate should file an Affidavit on Indian Stamp Paper duly attested by the Public Notaries authorized by the law. In the instant case as a Foreign national, it is not possible for him to submit such an Affidavit. The University considered the difficulties in this regard in detail and is pleased to issue the following directions, for those Foreign/NRI students who are constrained to get any Affidavits attested for such purposes.

- 1.The Envoys, Consuls and High Commissioners or other Officers authorized by them, of any INDIAN Embassy, Consulate, and the High Commission, respectively at various Foreign Nations are competent to attest the Affidavits made by student stakeholder NRIs and Foreign Nationals, for the purpose of obtaining various Certificates from the University.
2. Affidavits attested by any Officers of a FOREIGN Embassy, Consulate, and High Commission, other than the authorized, as detailed above are NOT acceptable to the University.
3. In cases of the Affidavits duly attested in Indian Stamp Paper worth INR- 200 /- the stakeholders can submit the same directly to the University, if the Affidavits are not in the Stamp paper it should be adjudicated before the officer authorized by the District Collector Kottayam Kerala, and then submit it before the University.

As per the directions read (3), of the Hon. Vice Chancellor,
Orders are issued accordingly.
