<u>ORDER</u>

The University Grants Commission has granted autonomous status as an instrument for promoting academic excellence, to Rajagiri College of Social Sciences, Kalamassery, Affiliated to the Mahatma Gandhi University, vide the paper (1) read above, for a period of six years from 2014-'15 to 2019-2020. As the term of autonomy tends to be expired, the college has applied for extension of the autonomous status for a further period of ten years, vide the paper read (2) above. The University, upon the advice of State Government, considered the application and forwarded the same to the University Grants Commission for necessary action.

The University Grants Commission has communicated, vide the paper read (3) above, its decision to extend the autonomous status conferred upon Rajagiri College of Social Sciences, Kalamassery, Rajagiri PO, Kochi - 683104, Kerala, affiliated to the Mahatma Gandhi University for a further period of ten years from the session 2020-2021 to 2029-2030 and requested the University to issue necessary notification/order regarding extension of autonomous status of the college as per the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulation 2018 for Autonomous Colleges.

The Syndicate of the Mahatma Gandhi University, at its meeting held on 30/01/2021, considered the above letter of the University Grants Commission and resolved, vide the minutes read (4) above, to extend the autonomous status conferred upon Rajagiri College of Social Sciences, Kalamassery for a further period of 10 years from the academic session 2020-'21 to 2029-'30 on getting an affidavit from the Manager of the college to the effect that the college shall abide by the rules and regulations of University. The Manager of the college submitted the affidavit on 02.03.2021 and, accordingly, the autonomous status conferred upon Rajagiri College of Social Sciences, Kalamassery, Rajagiri P O,Kochi - 683104, Kerala, affiliated to the Mahatma Gandhi University has been extended for a period of ten years from the session 2020-2021 to 2029-2030.
