<u>ORDER</u>

The following resolutions are taken in the meeting of the MOOC Monitoring Committee for Organic Farming held online on 11.01.2021. The meeting was chaired by Vice Chancellor.

1. A Programmer is to be appointed on contract basis for the purpose of conducting MOOC Course on Organic Farming. MOOC Co-Ordinator is entrusted to take steps for appointing the Programmer on contract basis.

2. The Programmer appointed on contract basis has to be given training on Programming by State Institute of Educational Technology (SIET) for conducting MOOC course. Decided to transfer Rs.30,000/- to SIET for providing one month training to the Programmer at SIET, based on the letter No.258/SIET/ORG.FMG/MGU/2020 dated 28.12.2020 of Director ,SIET.

3. The MOOC course on Organic Farming being offered to UG students in affiliated colleges of Mahatma Gandhi University is to be made available to public also. For this measures are to be taken which include making necessary modifications in the course content as well as changing the terms and conditions of offering the course to public.

4. SIET has requested the following amount for renewing the server space and providing support service to Mahatma Gandhi University in connection with MOOC course on Organic Farming up to 31 st March 2021 vide letter No.258/SIET/ORG.FMG/MGU/2020 dated 28.12.2020 of Director, SIET.

Since only Rs.1,35,000/- is available in MOOC MGU account (Operated by Hon. Director, IUCOFSA, in the capacity of Co-ordinator of MOOC on Organic Farming), Rs 1,67,400/- is sanctioned (UO No 164/AD A9/2021/MGU Dated 08.01.2021) by the University to Dr. Santhosh P Thampi, Hon. Director, IUCOFSA.

Rs.3,02,400/- is transferred to SIET on 11.01.2021. The matter has been reported to MOOC Monitoring Committee.
