ORDER

The Members of Expert Committee in Business Management and the representatives of affiliated MBA colleges under the University vide ref (1) cited had submitted a representation for streamlining the examinations which were postponed due to COVID -19 Pandemic, formatting the question paper pattern of ' MB 01 0302- Business Ethics and Corporate Governance' , 3rd Semester Core Course in accordance with the Regulations of the Course so as to facilitate preparation of the Question Bank and for extending the provisions of U O No.1916/AC A4/2020/MGU dated 2.5.2020- guidelines for conducting the **INTERNSHIP (First year) and RESEARCH BASED PROJECT (Second year) for the present batches.**

The Hon'ble Vice Chancellor studied the matter and ordered to seek remarks of Dean SMBS in this regard wherein the Dean pointed out the following,

1.Question paper Pattern: Unlike the question paper format for the Core and Elective courses where 17 questions grouped in three sections A, B and C are given, the Question pattern for 'Business Ethics and Corporate Governance' course will have only one section with 5 cases. Students are required to analyse and present their solutions to any 3 cases out of 5. Since this subject (Course) is unique in its pedagogy and evaluation as prescribed by AICTE, necessary changes need to be brought in to accommodate questions in this format in the Question paper software of the University and suggested the following format for the Core Course MB010302 "Business Ethics & Corporate Governance":

- Five cases not exceeding 1500 words are to be submitted by the question bank committee for each module. (5 cases 5 modules). Hence a minimum of 25 cases are to be prepared by the committee for inclusion in the software.
- The question bank software is expected to select one case from each module for the examination.
- The candidates are expected to attempt 3 cases out of 5 in the examination (Each case 20 marks).

In order to conduct the S3 MBA examinations by the mid of April 2021, these changes are to be programmed and incorporated in the software urgently.

2. INTERNSHIP (First year) and RESEARCH BASED PROJECT(Second year):

In view of the COVID pandemic which is prevailing at the moment and also the new wave of increase in infections, it would be appropriate for the University to follow the same guidelines prepared last year for internship and research based project.

On considering the urgency of matter, vide ref(3) above, the Hon'ble Vice Chancellor, exercising powers of Academic Council under Section 10(17) of Chapter 3 of MG University Act, 1985, has approved the above recommendations .
