ORDER

Applications for the post of Assistant Professor, Associate Professor and Professor in the various departments of the University, were invited as per paper read as (1), (2) & (3) above.

The Standing Committee of the Academic Council held on 17.12.2020 considered the matter of preparation of the criteria for the recruitment of candidates for appointment as Assistant Professor, Associate Professor and Professor in the teaching departments of the University from among the applicants who have submitted applications as per the notifications cited and resolved as follows:

"Resolved to recommend to follow the UGC Regulations 2018 for the recruitment to the post of Assistant Professor, Associate Professor and Professor in the University Departments with modifications as detailed below:

1. Assistant Professor:

- The Score sheet for the interview be prepared by converting the score calculated for short listing as per table 3A of the UGC Regulations to eighty and fixing the marks for interview as twenty thereby bringing the total score to hundred.
- Candidates who have scored less than 40 (forty) marks as per table 3A of the UGC Regulations (for SC/ ST candidate 35 (thirty five) marks) shall not be called for interview.

2. Associate Professor & Professor

• Instead of "Publications in peer-reviewed journals", "Publications in Scopus/ SCI indexed peer reviewed or UGC-CARE listed journals" only be considered for the purpose of calculation of research score.

• Prepare a final score sheet based on table 2 and interview.

The Vice Chancellor by exercising the powers as provided in Chapter III, Section 10(17) of the Mahatma Gandhi University Act 1985,has approved the above resolution of the Academic Council Standing Committee. Accordingly, University Order Number 2169/ADA2/2021/MGU dated 23.04.2021 has been issued. The above action taken by the Vice Chancellor and the issuance of University Order thereafter have been reported to the Syndicate. The Syndicate vide paper read as (5) above resolved as follows:

"The action taken by the Vice Chancellor by exercising the powers under Section 10 (17) of Chapter III of the Mahatma Gandhi University Act, 1985 and consequent issuance of U.O.No. 2169/ADA2/2021/MGU dated 23.04.2021, were reported to the Syndicate."
