ORDER

Notification was issued inviting applications from Unaided Self Financing Arts and Science Colleges for new programmes during the academic year 2020-21, vide paper (1) read above. The applications for starting new programmes submitted by the Principals of IHRD Colleges, namely College of Applied Science, Marayoor, College of Applied Science, Puthuppally and College of Applied Science, Kaduthuruthy, vide paper read (2) above, were considered by the University and Inspection Commissions were constituted, vide paper (3) read above, to assess the instructional and infrastructural facilities provided by these colleges to start the proposed programmes.

The Syndicate Sub Committee on Affiliation & Approval examined the Inspection Commission Reports in detail and the recommendations of the University to start the proposed programmes were forwarded for the NOC of the Government of Kerala vide paper read (4) & (5) above.

Government of Kerala, vide paper (6) above, accorded administrative sanction to the above mentioned Self Financing Colleges for starting new programmes during the Academic Year 2020-21.

It was decided, vide U.O read (7) above, to grant provisional affiliation to the programmes subject to the condition that Self-Financing Managements sign an agreement with the Government, submit a copy of the same to the university along with an affidavit of submission of the same to the Department of Higher Education and to submit an agreement with prescribed clauses, signed, to the University.

Meanwhile, Additional Chief Secretary, Higher Education (J) Department vide paper read (8) above stated that IHRD being a Government established institution, it is not necessary to sign the agreement with the Government while starting new courses, as in the case of other unaided self financing arts & science colleges. Considering this, the Syndicate sub committee on Affiliation & Approval recommended to grant provisional affiliation to new programmes in the above mentioned IHRD Colleges for the academic year 2021-22, vide paper (9) read above.

The Vice-Chancellor considered the above recommendation of the Syndicate sub committee on Affiliation & Approval and has accorded sanction for provisional affiliation to the PG programmes in the following colleges, for the academic Year 2021-22, by exercising powers under Section 3.10 (17) of the Mahatma Gandhi University Act, 1985:-

The affiliation granted shall be subject to the compliance of Act/Statutes/bye-Laws/rules and regulations of the University and UGC on instructional and infrastructural facilities, faculty, qualifications etc. by the colleges.

Provisional affiliation is granted subject to the following conditions:

1. The provisional affiliation is granted initially for a period of one Academic Year only.
2. The affiliation of programmes is subject to the approval of regulatory authority if any.
3. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
4. As per G O read (6) above, the Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.

d. The details of tuition fee and other fees are as detailed below:

b) Students insurance premium @ Rs.25/- per student per year.

c) Students welfare fund @ Rs. 30/- per student per year.

d) University Union fee @ Rs. 55/- per student per year.

e) Sports affiliation fee @ Rs. 210/- per student per year to be utilised in the ratio @ 50:50 by the University and the college.

f) The collection of annual administration fee from the students under any circumstances is not permitted.

g) Student's affiliation fee @ Rs. 550 & 750 /- for UG & PG courses collected on one time basis from all students shall be remitted to the university within 15 days after closing of the admission.

5. The rate of Tuition Fee is as per Government/ University orders issued from time to time.

6.The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time in so far as they are related to the college, and to appoint and fix the service conditions of the teaching & non teaching staff in the college for conducting the courses as followed by the Government on conducting similar courses. The Principal of the college shall endorse the undertaking.

7.The Educational Agency will agree to collect only such fees as determined by the Government/ University from time to time from the students admitted to the course

8.The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.

9.Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any prior notice.

Orders are issued accordingly.
