ORDER

As per the directives of AICTE, the duration of MCA programme has been reduced to two years from 2020-21 academic year onwards. The Regulation, Scheme and Syllabus of the MCA programme was restructured accordingly and the syllabus of the programme was approved as per the University Order referred to as 1 above.But due to some ambiguities in the grading pattern of the proposed Regulations,the same had been placed for the clarifications of the present Board of Studies.

The Board of Studies in Computer Applications (PG) vide paper (2) above had submitted the finalised Scheme of the Programme along with the following modifications in the proposed Regulations of the course.

1. Total Credit of the MCA programme will be 90 evaluated using indirect grading system with no separate minimum for internal evaluation.

2. To implement the Regulations with minimum passing criteria of not less than E (not less than 50%) grade for passing a course, a minimum SGPA not less than E (not less than 5) grade for semester pass and minimum CGPA of not less than 5 for the award of degree.

3.Conversion formula for CGPA to Percentage is CGPA obtained × 100/Maximum CGPA(=10)

The above recommendations of the Board of Studies was placed for the consideration of the Vice Chancellor who has approved the same by exercising powers under section 10(17), Chapter 3 of MGU Act 1985. Further, the course code given in the approved syllabus for the 3rd Semester subject Python Programming for Data Science-MCACT305 remains corrected as MCACP305. Orders are issued accordingly modifying the UO referred to as 1st above to the that extent only.
