ORDER

The meeting of the Syndicate Standing committee on Research and Development, vide minutes read as (1) above, resolved to recommend the following modifications, to be incorporated in the Mahatma Gandhi University Ph.D. Regulations, 2016 (in the clauses 18.1, 18.4 and 34);

18. Supervising Teachers in Approved Research Centres

18.1 - Only regular and approved teachers of the Government and Aided Colleges and permanent teachers of self supporting colleges (properly constituted appointing authority) having two years of teaching experience in the same college, affiliated to Mahatma Gandhi University and permanent scientists with Ph.D. in approved national institutions established either by the State Government or Central Government Act for the promotion of research within the State are eligible to act as research supervisors in their respective research centre. The guides should have minimum of three years of remaining service on the date of application.

18.4 - To be recognized as a research supervisor in a particular subject, the candidate must have a Doctorate Degree in the concerned/relevant/allied subject obtained from Mahatma Gandhi University or from other Universities recognized by Mahatma Gandhi University and the University Grants Commission. Such a person shall have at least two research publications in his/her subject, after the award of Ph.D. Degree published in UGC-CARE list of the journals of national/international standing. Provided in area/disciplines where there is no or only a limited number of refereed/peer reviewed journals, the Vice-Chancellor, on the recommendations of the University Research Committee, shall relax the above condition for recognition of a person as Research Supervisor.

34 De-registration and Re-registration

The clause 34.1 to 34.4 shall also be applicable to the candidates who have registered under 2010 Regulations.

The Hon. Vice Chancellor on 29.11.2021, by exercising powers under section III.10 (17) of the Mahatma Gandhi University Act 1985, approved the above recommendations with direction to issue orders and to report the matter to the Syndicate.

Orders are issued accordingly.
