ORDER

The University had given affiliation to B.Voc Programmes in various aided arts & science colleges with the financial assistance of UGC and the Government of Kerala had issued NOC vide paper read (1) &(2) above.

Vide the government order read paper (2) above, it is clearly stated that, "*the colleges may continue the course in the self financing stream by executing an agreement with the Government once the UGC assistance ceases and also that the colleges may ensure the NAAC score of 2.5 is attained or renewed for the continuation of the course by 2020*"

Upon cessation of financial assistance by UGC in the academic year 2020-21, the Principals/Managers of various Colleges have submitted applications vide paper (3) read above, for continuing the B.Voc Programmes in self financing mode in the academic year 2021-22 .

The Inspection Commission constituted vide paper read(4) above, assessed the facilities available in the colleges for continuing the B.Voc programmes in self financing mode and submitted the reports with recommendations accordingly.

By considering the reports submitted by the inspection commission, the syndicate has decided to give sanction to continue the course in self financing mode in the academic year 2021-'22, vide paper read as (4) above.

The Vice- Chancellor by exercising power u/s III.10(17) of the Mahatma Gandhi University Act 1985 has modified the above decision of the syndicate as follows,

"Due to the completion of financial assistance from the UGC for programmes started in 2018-'19 vide paper read (1) above, the college can continue the programmes in self financing mode in

2021-22 by submitting an affidavit from the principal /manager, stating that the NOC from state government will be submitted to the university on or before 31st January 2022".

The provisional affiliation for the above programmes is subject to the verification of the compliance of the Act/Statutes/bye-Laws/rules and regulations of the University and UGC on instructional and infrastructural facilities, faculty qualifications etc.

Provisional affiliation is granted subject to the following conditions:

1. The Provisional affiliation is granted initially for a period of one Academic Year only.
2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
3. Seats shall be filled up as per the reservation norms prescribed for the self financing course.
4. Management shall remit an amount of Rs. 42000/-(Forty two thousand rupees only) per course towards course affiliation fee.
5. The management shall also remit the following fees to the University.

Student Affiliation Fee	Rs. 550&750/- for UG&PG courses collected on one time basis from all students shall be remitted to the University within 15 days after closing for the admission.
Sports Affiliation Fee	Rs 210/- per student per year to be utilised in the ratio @ 50:50 by the University and the college
University Union Fee	Rs 50/- per student per year
Students Welfare Fund	Rs 30/- per student per year
Students Insurance Premium	Rs 23/- per student per year
Matriculation Fees	Rs.250/-per student

6. The rate of Tuition Fee and Annual Administration Fee is as per University and Government orders issued from time to time.

7. The Educational Agency should obey the conditions stated in G.O.(Ms) No. 127/2019/H.Edn. dated. 08/05/2019 in a time bound manner

8. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs.100/-to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations

and the directions issued by the University from time to time in so far as they are related to the College, and to appoint and fix the service conditions of the teaching and non-teaching staff in the College for conducting the Programmes as followed by the Government on conducting similar programmes. The Principal of the College shall endorse the undertaking.

9. The College shall submit the list of students admitted and remit the fees to University within 15 days after closing admission.

10. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any prior notice.

Orders are issued accordingly.
