ORDER

The Principals/Managers of various unaided Law Colleges vide paper (1) read above, have requested to grant extension of provisional affiliation to their colleges and courses for the Academic Year 2021-22.

The University considered the applications submitted by these colleges and Inspection Commissions were constituted vide paper (2) read above, to assess the infrastructural and instructional facilities available in the colleges for granting the extension of provisional affiliation for the Academic Year 2021-22. The Commissions have duly submitted reports recommending the extension of provisional affiliation to these unaided colleges and courses for the Academic Year 2021-22.

Considering the above, the Syndicate Sub Committee on Affiliation, vide paper (3) read above, recommended to grant extension of provisional affiliation to the five unaided Law Colleges and their courses. The Vice- Chancellor, exercising powers under Chapter III, Section 10(17) of Mahatma Gandhi University Act 1985, has approved the above recommendation and granted provisional affiliation to the five unaided Law Colleges and their courses for the Academic Year 2021-22 as detailed below:

5. Non-Compliance with any of the above conditions would lead to the withdrawal of the affiliation without prior notice.
