ORDER

The Bar Council of India vide paper read as (1) above has granted approval for 10% additional seats for the academic year 2020-21 over and above sanctioned strength of seats already existing per course in Three Year LL.B and Five Year B.Com LL.B courses conducted by Govt. Law College, Ernakulam under the prevalent Covid 19 pandemic situation. It is made clear that this approval/permission is granted only for the academic year 2020-21 under the special and extraordinary situation that has arisen. This will not be allowed or continued in future that is, with effect from the academic year 2021-22.

The matter was considered by the Syndicate of the University vide paper read as (2) above and decided to grant permission for 10% additional seats for the academic year 2020-21 over and above sanctioned strength of seats already existing per course in Three Year LL.B and Five Year B.Com LL.B courses conducted by Govt. Law College, Ernakulam under the prevalent pandemic situation after levying an amount of Rs.2100/- as fee for marginal increase, for each batch of the degree course.

Thus the number of seats for each course in Govt, Law College, Ernakulam for the academic year 2020-21 is as shown below:
