<u>ORDER</u>

The University Grants Commission has granted autonomous status as an instrument for promoting academic excellence, to Sacred Heart College, Thevara, Kochi, Affiliated to Mahatma Gandhi University, vide the paper (1) read above, for a period of six years from 2014-'15 to 2019-2020. As the term of autonomy tends to be expired, the college has applied for the extension of autonomous status for a further period of ten years, vide the paper (2) read above. The University, upon the advice of State Government, considered the application and forwarded the same to the University Grants Commission for necessary action.

The University Grants Commission has communicated, vide the paper read (3) above, its decision to extend the autonomous status conferred upon Sacred Heart College, Thevara, Kochi, Kerala - 682013, affiliated to Mahatma Gandhi University for a further period of five years from the session 2021-2022 to 2025-2026, including ex-post-facto approval for the period 2020-2021, and requested the University to issue necessary notification/order regarding extension of autonomous status of the college ..

The Syndicate of the Mahatma Gandhi University, at its meeting held on 02/09/2021, considered the above letter of the University Grants Commission and resolved, vide the minutes read (4) above, to extend the autonomous status conferred upon Sacred Heart College, Thevara, Kochi, from the academic session 2020-2021 to 2025-2026 on getting an affidavit from the Manager of the college to the effect that the college shall abide by the rules and regulations of Mahatma Gandhi University. The Manager of the college submitted the affidavit on 13.12.2021 and, accordingly, the autonomous status conferred upon Sacred Heart College, Thevara, Kochi, Kerala - 682013, affiliated to Mahatma Gandhi University has been extended from the session 2020-2021 to 2025-2026.

Orders are issued accordingly.
