## GOVERNMENT OF KERALA

### **Abstract**

Personnel & Administrative Reforms Department - Settlement of disputes between various Departments/ PSUs/ Corporations/ Boards/ Autonomous bodies - Committee re-constituted- Guidelines issued.

### **ORDER**

Government had constituted a High Power Committee for settlement of disputes between various departments/PSUs/Corporations/Boards/Autonomous bodies etc. as per Govt. orders read as 1<sup>st</sup> and 2<sup>nd</sup> paper above. Later, in order to provide an effective co-ordination for resolution of disputes between departments, Government had re-constituted the committee vide G.O. read as 3<sup>rd</sup> cited. The said Committee has been entrusted to examine the disputes and to submit suggestions. The suggestions of the Committee are being implemented with the approval of the council of Ministers.

However, it has come to the notice of the Government that certain Government Departments/ PSUs/ Corporations/ Boards/ Local Self Government institutions/ Autonomous bodies are still approaching various courts, tribunals and other legal forums for resolving disputes spending huge amounts of money as court fees and procedural expenses and thereby wasting time and resources by neglecting the standing orders on dispute redressal. Such practices need to be dispensed with in order to reduce the burden on the Government exchequer, and to avoid delay in administration and project

implementation. Hence there is a necessity for strengthening the administrative mechanism for resolution of disputes between and among departments/ PSUs/ Corporations/ Local Self Institutions/ Autonomous bodies etc.

Government have examined the matter in detail and are pleased to reconstitute the inter departmental dispute resolution Committee with the following members.

Also, in order to strengthen the dispute resolution system, the following guidelines are also issued for strict compliance:

The dispute raised by a Government organization against another shall be referred to the Secretaries of the departments involved in the dispute. The PSUs/ Corporations/ Local Self Institutions/ Autonomous bodies etc shall approach the Secretaries of their Administrative Department concerned. After the Secretaries of the disputing parties arrive at a settlement, a copy of the same shall be communicated to each party of the dispute for implementation. The need for litigation will thereafter be avoided.

#### THE NO.AK 13-2/140/2021-PandAKD

- In case the disputes remains unresolved after deliberation by the concerned Government Secretaries, the dispute shall be referred for dispute resolution to the Committee constituted by the Government as above.
- This committee shall examine the dispute and resolve the same. If any solution requires approval of the competent authority, it shall be obtained before implementation. In case recourse to legal measures are required, the committee shall be competent to grant permission for the same.
- If any of the Government Departments/ PSUs/ Corporations/ Boards/ Local Self Government institutions/ Autonomous bodies etc approaches the Courts/Tribunals/legal forums without clearance from the above committee, the entire cost of such litigation including interest thereof will be considered as wasteful expenditure and will be recovered from the officer who has authorized such filing of cases.
