### AMENDMENT TO THE MAHATMA GANDHI UNIVERSITY STATUTES, 1997

#### **AMENDMENT NO.27**

In exercise of the powers conferred by Section 23 (ii) of the Mahatma Gandhi University Act, 1985, the Syndicate of the University at its meeting held on 24.05.2021 (item no.202/21.02/39129/ACA5-3/2020/SPESS) has made the following amendments to the Mahatma Gandhi University Statutes, 1997.

In the said Mahatma Gandhi University Statutes, 1997, Statute 1 of chapter 11 is amended as follows:

1. Item No.18 of Statute 1 under chapter 11 of Mahatma Gandhi University Statutes, 1997 shall be replaced by

**18. "The Faculty of Physical Education and Sports Sciences"**


2. In the said Statutes in chapter 11, the existing item No.18 shall be renumbered as 19.

The above statutes, as amended, read as follows:-

18. The other faculties as may be instituted by the University from time to time not inconsistent with the provision of the Act.	18. The Faculty of Physical Education and Sports Sciences.
.....	19. The other faculties as may be instituted by the University from time to time not inconsistent with the provision of the Act.

The above amendments shall be deemed to have come into force from 2016-2017 academic year. These amendments have been assented to by the Hon'ble Chancellor on 27.02.2022 as intimated by the Principal Secretary to the Governor vide letter No. GS5-2451/2021 dated 03.03.2022.
