2. In the event of the research fellow not conforming to the said rules and instructions or of adverse reports regarding the progress of his/her research of his/her conduct or of his/her discontinuing his/her research in the research centre before the expiry of the full period, for not beyond his/her control, the research fellow and the sureties shall on demand pay to the University the Fellowship amount paid for and on behalf of the fellow in respect of his/her undergoing the course of research at the research centre.

3. It is hereby declared that during the tenure of this fellowship, the fellow will not hold any other fellowship except to the extent otherwise provided in the rules made by the Syndicate in this respect.

4. It is hereby further expressly agreed that all sums found due to the University under or by virtue of this agreement shall be recoverable jointly and severally from the fellow and the sureties and their properties movable and immovable in such manner as the University may deem fit.

5. The liability of the Sureties under this agreement is co extensive with that of the fellow and shall not be affected by the University giving time or any other indulgence to the fellow.
