<u>ORDER</u>

An extension of research period up to six months (from 01.01.2022 to 30.06.2022) was granted to research scholars for submission of thesis, as per U.O. cited (1) above.

In continuation to the UGC Public Notice dated 01.12.2021 regarding the extension of date of submission of thesis for terminal M.Phil / Ph.D students, and keeping in view of the larger interest of the research scholars, the University Grants Commission, vide Public Notice read as (2) above, decided to give an extension of up to six months, beyond 30.06.2022, to the students by their respective Higher Educational Institutions, on case-to-case basis, based on the review of student's work by the Research Advisory Committee and on the recommendation of the Supervisor and the Head of the Department of each individual case. Such extension may also be granted for submitting evidence of publication and presentation in two Conferences. However, tenure of fellowship will remain up to five years only.

The meeting of the Syndicate, vide minutes read as (3) above, resolved to endorse the above UGC Public Notice in the University.
