Provisional affiliation was granted to KMP College of Arts and Science, Asamannoor P.O., Perumbavoor vide paper read (1) above. The affiliation of the said college was cancelled due to lack of infrastructure facilities vide paper read (2) above.

The application submitted vide paper read (3) above, to restart KMP College of Arts and Science, Asamannoor P.O., Perumbavoor, Ernakulam for the academic year 2021-'22, was considered by University and an Inspection Commission was constituted vide paper read (4) above, to asses the instructional and infrastructural facilities provided by the educational agency to aforesaid college. Syndicate 24/05/2021 and restart the The meeting held on 08/07/2021 respectively, considered the inspection commission's report and resolved to accept the report and restart the said college subject to the approval of the Government, vide paper read (5) Subsequently, the University order vide paper read (7) was issued. The and (6) above. University to restart the above mentioned college was forwarded to recommendation of the Government of Kerala for obtaining NOC, vide paper read (8) above.

The Government of Kerala vide paper read (9) above, has issued NOC for restarting KMP College of Arts and Science Asamannoor P.O., Perumbavoor, Ernakulam during the Academic year 2022-'23.

In the light of the above Government order, vide paper read (9) above, the Pro-Vice Chancellor in charge of Hon'ble Vice Chancellor has ordered to grant provisional affiliation to KMP College of Arts and Science, Asamannoor P.O., Perumbavoor, Ernakulam, PIN: 683 549 with the following programmes, for the academic year 2022-'23.

Provisional affiliation is granted subject to the following conditions:

- 1. The provisional affiliation is granted initially for a period of one Academic Year only.
- The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
- 3. The Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.

- b) Students insurance premium @ Rs.23/- per student per year.
- c) Students welfare fund @ Rs. 35/- per student per year.
- d) University Union fee @ Rs. 55/- per student per year.
- e) Sports affiliation fee @ Rs. 225/- per student per year to be utilised in the ratio @ 50:50 by the University and the college.
  - f) The collection of annual administration fee from the students under any circumstances is not permitted.
- g) Student's affiliation fee @ Rs. 600/- for UG courses collected on one time basis from all students shall be remitted to the university within 15 days after closing admission.
- 4. The rate of Tuition Fee is as per Government/University orders issued from time to time.
- 5. The Educational Agency shall remit Rs.2,20,500/- (Rupees Two Lakh Twenty Thousand Five Hundred only) to Mahatma Gandhi University Fund towards initial affiliation fee for new college and also remit course affiliation fees for the above mentioned courses.
- 6. The Educational Agency shall furnish a Financial Guarantee of Rs. 3,00,000/- (Rupees Three Lakh only) as provided in Mahatma Gandhi University Statutes, 1997, by way of either of the following:
  - Cash Deposit.
  - Fixed Deposit in the State Bank of India or in any one of the Nationalized Banks, having Acquisition and Transfer of Undertaking. The Receipt being endorsed in the name of the Finance Officer, Mahatma Gandhi University.
  - · Government Securities.
  - Saving Certificates, National, Postal or Defence Bonds in favour of the Finance Officer.
  - Mortgage of the title deed of immovable property other than the College sites, buildings/hostels, where such mortgage is permitted under any law for the time being in force.

- 7. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time, so far as they are related to the college, and to appoint and fix the service conditions of the teaching & non teaching staff in the college for conducting the courses as followed by Government on conducting similar courses. The Manager of the college shall endorse the undertaking.
- 8. The Educational Agency will agree to collect only such fees as determined by Government/ University from time to time from the students admitted to the course.
- 9. The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.
- 10. The Educational Agency shall furnish the financial guarantee within one month from the date of sanctioning affiliation.
- 11. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation Ng O'leading to Ok without any prior notice.
