### **ORDER**

The application submitted by The Principal, College of Applied Science, Peermade, vide paper read (1) above, for starting B.Com Model III Taxation (40 seats) in the college during the academic year 2022-'23 was considered by the University and an Inspection Commission was constituted vide paper read (2) above, to assess the instructional and infrastructural facilities provided by the educational agency to start the proposed programme.

The Syndicate Sub Committee on Affiliation and Approval held on 28.06.2022 vide paper read (3) above, examined the Inspection Commission report in detail and recommended to grant provisional affiliation in accordance with the Government NOC. The Hon'ble Vice Chancellor approved the recommendation, exercising powers under section 3.10(17) of the Mahatma Gandhi University Act 1985 and University order was issued accordingly, vide paper read (4) above. The recommendation of the University to start the proposed Programme was forwarded for the views of the Government of Kerala, vide paper (5) read above.

The Government of Kerala, vide paper (6) above, have accorded administrative sanction for starting the new Programme B.Com Model III Taxation during the Academic Year 2022-'23.

paper read (7) above, to furnish a copy of signed agreement with the Government along with an affidavit of submission of above to the Department of Higher Education and submit a signed agreement with prescribed clauses, to the University.

Sanction has therefore been accorded by the Vice Chancellor to the college, who satisfied the conditions laid by the University for starting the new Programme, B Com Model III Taxation during the academic year 2022-'23 and to duly include these courses in the CAP 2022-'23.

The affiliation granted shall be subject to the compliance of Act/Statutes/bye-Laws/rules and regulations of the University and UGC on instructional and infrastructural facilities, faculty, qualifications etc. in the college.

Provisional affiliation is granted subject to the following conditions:

- 1. The provisional affiliation is granted initially for a period of one Academic Year only.
- 2. The affiliation of programme is subject to the approval of regulatory authority if any.
- 3. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
- 4. As per G O read (6) above, the Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.

- b) Students insurance premium @ Rs.23/- per student per year.
- c) Students welfare fund @ Rs. 35/- per student per year.
- d) University Union fee @ Rs. 55/- per student per year.
- e) Sports affiliation fee @ Rs. 225/- per student per year to be utilised in the ratio @ 50:50 by

the University and the college.

- f) The collection of annual administration fee from the students under any circumstances is not permitted.
- g) Student's affiliation fee @ Rs. 600 & 800 /- for UG & PG courses collected on one time basis from all students shall be remitted to the university within 15 days after closing admission.
- 5. The rate of Tuition Fee is as per Government/University orders issued from time to time.
- 6. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs.100/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time, so far as they are related to the college, and to appoint and fix the service conditions of the teaching & non teaching staff in the college for conducting the courses as followed by the Government on conducting similar courses. The Principal of the college shall endorse the undertaking.
- 7. The Educational Agency will agree to collect only such fees as determined by the Government/University from time to time from the students admitted to the course.
- 8. The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.
- 9. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any prior notice.
