**ORDER**

An application was submitted vide paper read (1) above, by the Chairman, Vinjyan Foundation, Elanji for starting a new Unaided Self Financing Arts and Science College by the name and style 'VISAT Arts and Science College, Mutholapuram P.O., Elanji, Ernakulam- 686 665 for the academic year 2022-'23. The same was considered by the University and an Inspection Commission was constituted vide paper read (2) above to assess the instructional and infrastructural facilities provided by the educational agency to start the proposed college.

But, later on, the said agency filed a writ petition and obtained a favourable judgement directing the University to consider their application in the next Syndicate vide paper read (3) above. Considering the said court judgement and the application, the Syndicate meeting, held on 8th April 2022, directed to resubmit the file after the completion of registration of minimum land criteria (5 acres) required for starting the college under the ownership of the

said educational agency and subsequent to this, an University Order was issued vide paper read (4) above. Accordingly, the said agency had resubmitted the application along with the copies of all relevant documents vide paper read (5) above.

Considering the above, an inspection commission was constituted to assess the submitted land documents and the related facilities required for starting a new college vide paper read (6) above.

The inspection commission submitted the report, dated 01/08/2022 and the Syndicate Meeting held on 23/08/2022 considered the inspection commission's report and resolved to approve the report and take steps for the implementation of the same, vide paper read (7) above and an University order was issued vide paper (8) above.

The recommendations of the University to start the above mentioned college was forwarded to the Government of Kerala for obtaining administrative sanction, vide paper read (9) above.

The Government of Kerala vide paper read (10) above, has granted administrative sanction for starting VISAT Arts & Science College, Mutholapuram P.O, Elanji, Ernakulam-686 665 during the academic year 2022-2023.

In the light of the Government order, vide paper read (10) above, the Hon'ble Vice Chancellor has ordered to grant provisional affiliation to VISAT Arts and Science College, Mutholapuram P.O, Elanji, Ernakulam- 686 665 with the following programmes, for the academic year 2022-'23.

Provisional affiliation is granted subject to the following conditions:

1. The provisional affiliation is granted initially for a period of one Academic Year only.
2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
3. The Educational Agency shall set apart 50% of the seats of the course for being filled up

by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.

b) Students insurance premium @ Rs.23/- per student per year.

c) Students welfare fund @ Rs. 35/- per student per year.

d) University Union fee @ Rs. 55/- per student per year.

e) Sports affiliation fee @ Rs. 225/- per student per year to be utilised in the ratio @ 50:50 by the University and the college.

f) The collection of annual administration fee from the students under any circumstances is not permitted.

g) Student's affiliation fee @ Rs. 600/- for UG courses collected on one time basis from all students shall be remitted to the university within 15 days after closing admission.

4. The rate of Tuition Fee is as per Government/University orders issued from time to time.

5. The Educational Agency shall remit Rs.2,20,500/- (Rupees Two Lakh Twenty Thousand Five Hundred only) in Mahatma Gandhi University Fund towards initial affiliation fee for new college and also remit course affiliation fees for the above mentioned programmes.

6. The Educational Agency shall furnish a Financial Guarantee of Rs. 3,00,000/- (Rupees Three Lakh only) as provided in Mahatma Gandhi University Statutes, 1997, by way of either of the following:

- Cash Deposits
- Fixed Deposit in the State Bank of India or in any one of the Nationalized Banks, having Acquisition and Transfer of Undertaking. The Receipt being endorsed in the name of the Finance Officer, Mahatma Gandhi University.
- Government Securities.
- Saving Certificates, National, Postal or Defence Bonds in favour of the Finance Officer.
- Mortgage of the title deed of immovable property other than the College sites, buildings/hostels where such mortgage is permitted under any law for the time being in force.

7. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time in so far as they are related to the college, and to appoint and fix the service conditions of the teaching & non teaching staff in the college for conducting the courses as followed by the Government on conducting similar courses. The Manager of the college shall endorse the undertaking.

8. The Educational Agency will agree to collect only such fees as determined by the Government/University from time to time from the students admitted to the course.

9. The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.

10. The Educational Agency shall furnish the financial guarantee within one month from the date of sanctioning of affiliation.

11. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any prior notice.
