# **ORDER**

As per the U.O. read as paper (1) above, affiliation was granted to the U G C sponsored B.Voc. Tourism & Hospitality Management Programme in Henry Baker College, Melukavu subject to the concurrence of the Govt.. The Government of Kerala vide its order read as paper (2) above, issued NOC for the conduct of the aforementioned programme in Henry Baker College, Melukavu, on condition that, "the college shall continue the course in the self financing stream by executing an agreement with the Government once the UGC assistance ceases and also that the college shall ensure the NAAC score of 2.5 is attained or renewed for the continuation of the course by 2020"

Upon cessation of the financial assistance by the UGC in the academic year 2020-'21, the Principal, Henry Baker College submitted application for continuing the B.Voc. Programme in self financing mode during the academic year 2021-'22. Since the College did not have the requisite NAAC accreditation score (2.5), the University vide order read as paper (4) above, stopped admission to the B.Voc. programme in Henry Baker College, Melukavu from the academic year 2021-'22.

When the College attained the required NAAC score to continue the programme in self-financing mode, the manager of the College submitted another application seeking affiliation to the aforesaid programme in self financing mode, in the academic year 2021-'22.

Considering the application, the University constituted an Inspection Commission to assess the facilities in the College for continuing the programme. Based on the report of the Inspection Commission, the University vide order read as paper (6) above, granted affiliation to the programme in self financing mode, for the academic year 2022-'23 subject to the concurrence of the Government.

The Government vide its order read as paper (7) above, accorded administrative sanction to Henry Baker College, Melukavu, for starting B.Voc. Tourism & Hospitality Management Programme in self-financing mode from the academic year 2022-'23.

Having considered all these aspects, the Syndicate at its meeting held on 22.10.2022 vide minutes item read as paper (8) above, resolved to grant provisional affiliation to the B.Voc. Tourism & Hospitality Management Programme in Henry Baker College, Melukavu, in self-financing mode, for the academic year 2022-'23.

The provisional affiliation for this programme is subject to the compliance of the Act/Statutes/Bye-Laws/Rules and Regulations of the University and UGC on instructional and infrastructural facilities, faculty qualifications etc.

Provisional affiliation is granted subject to the following conditions:

- 1. The Provisional affiliation is granted initially for a period of one Academic Year only.
- 2. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
- 3. Seats shall be filled up as per the reservation norms prescribed for the self financing course.
- 4. Management shall remit an amount of Rs. 44100/-(Forty four thousand and one hundred rupees only) per course towards course affiliation fee.
- 5. The management shall also remit the following fees to the University.

Student Affiliation Fee	Rs. 600&800/- for UG&PG courses respectively collected on one time basis from all students shall be remitted to the University within 15 days after closing of admission.
Sports Affiliation Fee	Rs 225/- per student per year to be utilised in the ratio @ 50:50 by the University and the college
University Union Fee	Rs 55/- per student per year
Students Welfare Fund	Rs 35/- per student per year
Students Insurance Premium	Rs 23/- per student per year
Matriculation Fees	Rs.265/-per student

6. The rate of Tuition Fee and Annual Administration Fee shall be as per University and Government orders issued from time to time.

- 7 . The Educational Agency shall furnish an undertaking in stamp paper worth Rs.100/- to the University pledging to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time in so far as they are related to the College, and to appoint and fix the service conditions of the teaching and non-teaching staff in the College for conducting the programmes as followed by the Government on conducting similar programmes. The Principal of the College shall endorse the undertaking.
- 8. The College shall submit the list of students admitted and remit the fees to the University within 15 days after closing of admission.
- 9. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without prior notice.

Orders are issued accordingly.
