ORDER

As per the paper read (1), sanction was accorded by the Hon'ble Vice Chancellor to entrust the Director, School of Pure and Applied Physics, to commence an Annual Maintenance Contract (AMC) with M/s. Bruker India (P) Ltd. Mumbai for the equipment Single Crystal XRD Machine in School of Pure and Applied Physics for Rs. 2,35,000/- + 18% taxes, for one year from 02.03.2022 to 01.03.2023, debiting the expenditure to the Head of Account '21 101 93 f - Establishment of Laboratory Maintenance' in the Budget Estimates for the year 2021-2022.

The Head of the Department concerned, vide paper read (2), has requested to pay the second instalment of AMC charges to the firm concerned.

The Finance Wing of the University concurred with the payment proposed.

Sanction has, therefore, been accorded by the Hon. Vice Chancellor to pay Rs. 1,38,650/- (Rupees One Lakh Thirty-eight Thousand Six Hundred and Fifty only) to M/s. Bruker India (P) Ltd. Mumbai for the second instalment of AMC charges for the Single Crystal XRD Machine in School of Pure and Applied Physics, debiting the expenditure to the Head of Account " 21 101 93f - Establishment of Laboratory Maintenance Facility - SBS, SCS, SPAP, SES" in the Budget Estimates for the year 2022-2023.
