**ORDER**

Sri. Shafeek S & Others, students of B Arch Course under the University and petitioners in WP(C) No.16174/2020 had approached the Hon'ble High Court challenging the University Order cited 2nd in so far as it restricts those failed candidates of the course who do not have 45% marks for University Theory examinations from re-doing the internal component (as per the UO, the candidates who have obtained at least 45 percent marks or above in the University theory examination under Group II subjects as well as the subjects under Group I namely Architectural Graphics and Visual Arts, but failed in the subject due to the shortfall in the continuous assessment (CA) marks alone are eligible to appear for re-do of their continuous assessment marks in that subject). But, since the judgement in the writ upheld the UO which mainly highlighted the aspect of academic standards, the petitioners challenged the order in WA No.1771 of 2020, seeking favourable orders for Internal re do, wherein the Court directed the University to substitute the 45% minimum marks fixed for theory papers as the eligibility for re-do of the internals with 40% marks (as fixed for regular chance and as being granted by other Universities for the same course) enabling the appellants and other similarly situated B.Arch students who have completed the course to re-do the internal assessment.

In compliance with the Judgement of the Hon'ble High Court referred to as 1st above, the Vice-Chancellor as per reference cited 3rd has approved the directions of the Hon'ble Court, exercising the powers under chapter III,10 (17) of the MG University Act of 1985, enabling the appellants and similarly situated B Arch students who have 40% marks for University Theory Examinations, but failed to get a pass in the subject, to re- do the respective internals.

Orders are issued accordingly, modifying the UO referred to as 2nd to that extent only.
