ORDER

University has issued guidelines for the entire selection process to the post of Assistant Professor in University Academic Schools/Departments and Private Colleges affiliated to the University vide U.O. read as (1) above.

Now, the combined meeting of the Deans of faculties and Heads of the Academic Schools/Departments of the University, resolved to recommend to prepare additional guidelines for the screening and selection process in University Academic Schools/Departments and the Hon.Vice Chancellor vide paper read as (2) above has approved the additional guidelines for the selection of Teachers in the university Schools/Departments by exercising the powers of the Academic Council under Chapter III section 10(17) of the Mahatma Gandhi University Act,1985.

The additional guidelines for the screening and selection process in University Academic Schools/Departments approved by the Hon. Vice Chancellor are as detailed below.

1. The Screening and the Selection Committees shall be empowered to exercise their discretionary power by virtue of academic/research excellence to assess the quality of publications in peer reviewed /UGC CARE listed research journals for the purpose of preparing score sheets.
2. The Screening and the Selection Committees shall also be empowered to assess the quality of books/book chapters/research papers published in conference/seminar proceedings.
3. However, while disqualifying research publications/books/book chapters/research papers in seminar/conference proceedings for awarding of marks/points as per the score sheets (both screening and selection), claimed in the respective applications, reason for rejecting such research publications /books/book chapters/research papers must be recorded and signed by all the members of the Screening/Selection Committee either in the proceedings or separately.
4. Awards obtained for best paper presentation/poster presentation in seminar/conference etc, fellowships shall not be considered for awarding marks/points. The Screening and the Selection Committees shall be empowered to assess the quality of awards also.
5. Screening/Selection Committees shall consider only those credentials which have been uploaded/submitted along with the applications. Achievements/credentials/claims after the submission of applications shall not be considered for award of marks/points for short listing/selection.

6. Any claim in the application without supporting document(s) should be rejected by the Screening/Selection Committees.

The University Order read as (1) stands modified to this extent.
