The Academic Council vide the minutes item read as paper (2) above, resolved to revise the Admission Regulations for the B.Ed Programme in accordance with the following recommendations put forward by the Board of Studies in Education(UG), regarding the inclusion of Hearing Impaired(Partially Deaf) students in the Differently Abled Category Reservation for admission to the B.Ed Programmes conducted by the Training Colleges affiliated to the University from the Academic year 2023-'24:

**Recommendations of the Board of Studies in Education (UG)**

1. To admit Hearing Impaired (Partially Deaf) candidates for the B.Ed Degree Programme under PD Quota from 2023-'24 admission onwards. Those Hearing Impaired candidates who have the bench mark disability as per clause 32(1) of Chapter VI the Rights of Persons with Disabilities Act 2016, can be considered for reservation under PD Quota.
2. To make necessary modifications in the Prospectus of B.Ed programme of 2023-24 admission to incorporate the above mentioned candidates.
3. To admit those candidates to any subject of their choice, if they satisfy the eligibility conditions mentioned in the Prospectus.

The aforesaid resolution of the Academic Council was reported to the Syndicate at its meeting held on 10.04.2023 vide the minutes item read as paper (3) above.
