

(3) To add the following sub clause after sub clause 13.15 (A):

13.15(B) Betterment Programme-One time

A candidate will be permitted to improve the CGPA of the programme within a continuous period of four semesters immediately following the completion of the programme. The CGPA for the betterment appearance will be computed based only on the SGPA secured in the betterment appearance of each semester. Better SGPA secured in any semester in the original appearance will not be counted for calculating the CGPA of the betterment appearance, under any circumstance. If there is no increase in the CGPA in the betterment appearance, the original CGPA will stand.

(4) To add the following sub clause after sub clause 13.15 (B) :

Clause 13.15(C): Course improvements and one-time betterment of programme will not be allowed to candidates who pass the semester/programme availing supplementary chance.

The amendment to the regulations shall come in force with immediate effect.



ORDER

The "Regulations for post Graduate programmes under Credit Semester 2011" was promulgated vide U.O. read above. In this regulation, there was no provision for improvement of External examination of each course and betterment of the whole programme as such, if a candidate passes the same. Further, there was no provision for the failed candidate to reappear for Internal examination. The matter was brought to the notice of the Hon. Vice-Chancellor and a proposal for amendment was submitted.

Hence, considering the exigency, the Vice-Chancellor, exercising power of the Academic Council U/S.10 (17) of M.G.University Act. 1985 has approved the following amendments to the PG Programme Regulations for Credit Semester System (MGU-CSS-PG) 2011:

1) To amend Sub-clause 13.5 as follows:

"To ensure transparency of the evaluation process, the internal assessment grade awarded to the students in each course in a semester shall be published on the notice board at least one week before the commencement of external examination".

There shall not be any chance for improvement for internal grade/grade point. However, students who fail to secure the minimum grade required for a pass in the internal examination can 're-do' the internal examination along with the immediate junior batch. They shall apply for the examination following the procedure prescribed for supplementary candidates.

(2) To add the following sub clause after sub-clause 13.15:

13.15 (A) Improvement of Course

Candidates who wish to improve the grade/grade point of the external examination of a course/courses he/she has passed can do the same by appearing in the external examination of the concerned semester along with the immediate junior batch.
