NOTIFICATION

Sub:- Election to the Students' Council of the Mahatma Gandhi University by the full-time students of the departments of the University.

Ref: 1. Chapter IV, Section 29(2), Elected Members (b) of the Mahatma Gandhi University Act,1985

2. Statute 32 of Chapter 44 of the Mahatma Gandhi University Statutes 1997.

It is hereby notified that election will be held to fill up the vacancies in the Students' Council vide item (b) under the heading 'Elected Members' in Section 29 (2) of Chapter IV of the MGU Act 1985. The above election will be conducted in accordance with the system of proportional representation by means of single transferable vote.

STUDENTS' COUNCIL -SECTION 29(2) - Elected Members (b)

Three members elected from among the full-time students of the departments of the University in such manner as may be prescribed.

Only the students whose names are in the electoral roll are eligible to take part in the election. The full time students of the Departments/Schools/Centres coming under the University, as on the date of publication of the election notification are eligible to be enrolled in the electoral roll and to vote, subject to the provisions contained in the Statutes. Every Nomination Paper shall be proposed by an elector with his signature whose name is on the electoral roll and seconded by another elector with his signature. The candidate shall then sign a declaration on it, expressing his willingness to serve on the concerned University authority or body, if elected.

Nominations shall be made in the prescribed form, which shall, on application, be supplied free of cost by the Returning Officer to any elector whose name is on the electoral roll. Formats of the Nomination Papers are made available in the website of the University free of cost. The candidates shall either in person or by his proposer, deliver the nominations to the Returning Officer at his office.

Nomination paper shall reach the undersigned not later than 1.00 pm on 03.08.2023 The envelope containing Nomination paper should be superscribed "Election to the Students' Council - The full-time students of the departments of the University - Constituency"
