3. Tenders must accompany a copy of the “Annexure 2 and Annexure 3” section of this document, signed and stamped on each page indicating that they agree to these.
4. The non-refundable application fee of 0.2% of cost with the chalan of 5% of it as GST must be accompanied with tender for each instrument. The application fee must be as D.D. drawn in favour of **Principal Investigator, RUSA 2.0, Project No. 18, School of Tourism Studies, Mahatma Gandhi University, Kottayam**
5. The DD/Cheque for EMD or any other must be drawn in of favour of **Principal Investigator, RUSA 2.0, Project No. 18, School of Tourism Studies, Mahatma Gandhi University, Kottayam** payable at SBI Mahatma Gandhi University Campus Branch.
6. Instrument should have a warrantee of at least three year and should have at least one Service engineer and one application scientist based in India with onsite training facility on the same quoted equipment. Training should include operation, handling and maintenance of system.
7. A good record in supply and service to other research institutes will be considered as a positive point for a particular company. User list of similar equipment supplied recently in India should be provided.
8. Laboratory floor space, electrical power requirements, earthing, room temperature/ humidity requirements etc. should be mentioned appropriately.
9. All necessary accessories should be supplied with the instrument, as per standard package offered, including complete set of service and operation manuals for diagnosis, trouble shooting, maintenance and electronic circuitry (hard and soft copies).
10. The Delivery Schedule, Payment Terms & Warranty/Guarantee etc must be clearly indicated in the technical bid. The charges for extended warranty and/or Annual Maintenance Contract after the expiry of offered warranty period should also be specified in the financial bid.
11. The price of the equipment should be quoted in Indian rupee. The total price of the equipment quoted should be inclusive of GST & other taxes if any; material cost; transportation cost; loading and unloading cost; installation cost; labour charges and another expenses in whatsoever means.
