### **ORDER**

As per University Order read 1 above, the Syndicate decided to issue notifications to fill up the anticipated, NJD vacancies in the post of Assistant Professor, Associate Professor and Professor up to 01.07.2022 in various statutory departments of the University.

As per University Order read 2 above, the Vice Chancellor approved the directions to issue notification to the post of Assistant Professor, Associate Professor and Professor in various Schools of the University by exercising the powers under Section 3.10(17) of Mahatma Gandhi University Act 1985. The University Order read 2 was modified and accordingly University Order read 3 was issued. The above action taken by the Vice Chancellor by exercising the powers under Section 3.10(17) of Mahatma Gandhi University Act 1985 and the issue of University orders read 2 and 3 was reported to the Syndicate.

The meeting of the Syndicate held on 22.10.2022 resolved vide paper 4 above as follows:

"As per U.O.No. 6971/AD A2/2022/MGU dated 02.07.2022, the Syndicate decided to issue notifications to fill up the anticipated, NJD vacancies in the post of Assistant Professor, Associate Professor and Professor up to 01.07.2022 in various statutory departments of the University. The number of vacancies reported till 01.07.2022 are 12, 5 and 2 respectively in the post of Assistant Professor, Associate Professor and Professor.

Consequent to the above, sanction has been accorded by the Vice Chancellor by exercising the powers under Section 3.10(17) of Mahatma Gandhi University Act 1985 to issue notification to fill up the vacancies existing in the post of Assistant Professor, Associate Professor and Professor in the various University Departments in accordance with the directions given below:

- (i) PH backlog vacancies shall be included in the notification.
- (ii) As per Right of Persons with Disabilities Act, 2016, Clause 34.2 the unfilled vacancy due to non

availability of suitable person with benchmark disability may be filled by interchanging among other categories. Accordingly, the Assistant Professor vacancy reserved for PH- Orthopaedically Handicapped in the School of Indian Legal Thought shall be interchanged with that of PH-Cerebral Palsy/ Locomotor Disability in the School of Letters.

(iii) As per KSSR 1958, Rule 15(a), if no suitable candidate is available for selection from the respective community or a group of communities even after re-notification, repeatedly for not less than two times, the selection shall be made from other Backward Classes candidates. Therefore the post of Associate Professor reserved for Viswakarma Community in School of Pure and Applied Physics shall be transferred to Dheevara Community and that reserved for Muslim Community in School of Tourism Studies to the LC/ Al Community.

(iv) In order to avoid Court cases and other litigation, notification in the lien vacancy shall be issued only after the lien retained by the teacher ceases to exist in the appointed post as per the Kerala Service Rules in this regard. Accordingly University Order No.10001/AD A2/2022 dated 27.09.2022 was issued and later modified vide U.O. No.10177/AD A2/2022/MGU dated 01.10.2022.

The above action taken by the Vice Chancellor by exercising the powers under Section 3.10(17) of Mahatma Gandhi University Act 1985 and the issue of University orders U.O. No. 10001/AD A2/2022/MGU dated 27.09.2022 and U.O. No. 10177/AD A2/2022/MGU dated 01.10.2022 is reported to the Syndicate ."

Orders are issued accordingly.
