



# MAHATMA GANDHI UNIVERSITY, KERALA

### **Abstract**

Unaided Training College - 'Indira Gandhi Training College, Kothamangalam' - Provisional affiliation for the academic year 2022-'23, subject to the NOC from Government of Kerala - Compliance with the Judgment of the Hon'ble High Court of Kerala in WP (C) No. 1472/2023 - Sanctioned - Orders issued.

## **ORDER**

Complying with the Judgment of the Hon'ble High Court of Kerala in WP(C) No.30055/2022 provisional affiliation was granted to the unaided Training College named 'Indira Gandhi Training College, Kothamangalam' for the academic year 2022-'23, subject to the recognition of National Council for Teacher Education(NCTE).

The National Council for Teacher Education(NCTE) vide the continuation order read as paper 2 above, granted continuation of recognition to Indira Gandhi Training College, Survey No. 83/3,83/4A, 84/5, 83/5-C, 83/4-B, 84/6, 84/7, Ward X, Eramallor, Village Eramalloor, Nellikuzhi Panchayat, Kothamanagalam, Ernakulam District, Kerala -686691 for B.Ed. programme for two years duration with an annual intake of 1 basic unit of 50 students.

The University noticed that the Survey Numbers mentioned in the continuation order issued by the NCTE do not match with the Survey Numbers mentioned in the Form No.2(359/9B/1,359/9B/2/11, 359/9B/3/12, 358/1A/17) submitted by the Educational Agency and in the Inspection Report(360/12, 360/11-2B, 360/11-3C, 360/11A) of the Inspection Commission. The Educational Agency was informed vide letter read as paper 3 above, about the discrepancies in the Survey Numbers of the land properties wherein the Indira Gandhi Training College, Kothamanagalam is situated and was asked to obtain appropriately corrected recognition order

Meanwhile, the Indira Gandhi Memorial Trust, Kothamangalam filed WP(C) No.1472 of 2023 before the Hon'ble High Court of Kerala. The Hon'ble High Court in its Judgment dated 17.01.2023 in WP (C) No. 1472/2023 vide Judgment read as paper 4 above, directed the University to hear the petitioner and take a decision on the matter expeditiously.

In Compliance with the Court Order, the Convener of the Syndicate Sub Committee on Affiliation & Approval of the University was assigned to hear the General Secretary of the Indira Gandhi Memorial Trust. The Educational Agency was asked to bring the relevant land documents viz. Location sketch and plan duly attested by the Village Officer for the hearing.

The Convener of the Syndicate Sub Committee on Affiliation & Approval of the University heard the General Secretary of the Indira Gandhi Memorial Trust on 03.02.2023, who was represented by the Chairman of the Indira Gandhi Memorial Trust. The Chairman informed the Convener that the land under these Survey numbers belongs to the Indira Gandhi Memorial Trust and will obtain appropriate recognition order from the NCTE.

After considering all the relevant matters in detail and in compliance with the Court Order, the Convener of the Syndicate Sub Committee on Affiliation & Approval of the University has recommended the following.

"On assumption that the new college named 'Indira Gandhi Training College, Kothamangalam is located in the land properties with the survey numbers mentioned in the recognition order of the NCTE, the survey numbers mentioned in the application submitted by the trust and the survey numbers mentioned in the inspection report, the provisional affiliation granted for the academic year 2022-'23 can be regularised and;

- To direct the College to remit the amount towards security deposit for starting the new college and the associated fees.
- To direct the College authorities to obtain the NOC from the Government for regularising the provisional affiliation granted for the academic year 2022-'23.
- To direct the Institution to seek approval from the NCTE, specifying the location of the College in the land properties with the survey numbers shown in their application and in the inspection report of the Commission and submit the same to the University for renewal of the provisional affiliation of this new college for the academic year 2023-'24."

The Vice Chancellor, by exercising the powers under Chapter III, Section 10(17) of the Mahatma Gandhi University Act 1985 has approved the above recommendations.

The provisional affiliation granted is subject to the following conditions:

- 1. The provisional affiliation granted initially for a period of one academic year only.
- 2. The selection and admission of the students and commencement of classes for the said programmes in the college shall be in accordance with the rules and regulations of the University, the State Government and the National Council for Teacher Education(NCTE).
- 3. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
- 4. The Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such authority determined by the Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit provided they satisfy the eligibility conditions prescribed by the University.

a) The details of Tuition fee and other fees are as detailed below:

- b) Students Insurance Premium Rs.23/- per student per year
- c) Students welfare fund Rs.35/- per student per year
- d) University Union Fees Rs.55/- per student per year
- e) Sports Affiliation Fee due to the University Rs.225/- per student per year

- f) The collection of annual administration fee from the students under any circumstances is not permitted.
- g) Student's Affiliation fee Rs. 600/- collected on one time basis from all students shall be remitted to the University within 15 days after closing admission.
- 6. The rate of Tuition fee is as per Government orders issued from time to time.
- 7. The Educational Agency shall remit Rs. 3,30,750/-(Rupees Three Lakh Thirty Thousand Seven Hundred and Fifty Only) to Mahatma Gandhi University Fund towards initial affiliation fee for new college and also remit 33,075/-(Rupees Thirty Three Thousand and Seven Five Only) as course affiliation fees.
- 8. The Educational Agency shall furnish a Financial Guarantee of 3,00,000/-(Rupees Three Lakh only) as provided in Mahatma Gandhi University Statutes,1997, by way of either of the following:
  - Cash Deposits
  - Fixed Deposit in the State Bank of India or in any one of the Nationalized banks, having Acquisition and transfer of undertaking. The Receipt being endorsed in the name of the Finance Officer, Mahatma Gandhi University,
  - · Government Securities
  - Saving Certificates, National, Postal or Defence Bonds in favour of the Finance Officer.
  - Mortgage of the title deed of immovable property other than the College sites, buildings/hostels where such mortgage is permitted under any law for the time being in force.
- 9. The Educational Agency shall furnish an undertaking in stamp paper worth Rs 200/- to the effect that the institution will abide by the rules, regulations and instructions issued by the University, State Govt. and National Council for Teacher Education regarding the admissions to the programmes, appointment of the teaching and non teaching staff in the college for conducting the course from time to time. The Manager of the college shall endorse the undertaking.
- 10. The Educational Agency will agree to collect only such fees as determined by the Government/University from time to time from the students admitted to the course.
- 11. The College shall submit the list of students admitted and remit the fees due to University within 15 days after closing of admission.
- 12. There shall not be any financial commitment to the Govt/University.
- 13. The Educational Agency shall furnish the financial guarantee within one month from the date of sanctioning of affiliation.
- 14. The College authorities should obtain the NOC from Government of Kerala regularising the provisional affiliation of this new College for the academic year 2022-'23.
- 15. The College authorities should obtain recognition from NCTE with the survey numbers shown in the application and inspection report before renewing the provisional affiliation of this new college for the academic year 2023-'24.
- 16. Non-compliance with any of the above mentioned conditions will result in the withdrawal of the provisional affiliation granted to the college without any prior notice.
