Since the Educational Agencies could not obtain the NOC from the Government and approval of the Bar Council of India so as to facilitate starting the new unaided Law colleges in the academic year 2023-'24, they filed WP(C) No. 34243/2023, 34303/2023 &34353/2023 before the Hon'ble High Court of Kerala. The Hon'ble High Court of Kerala vide its Judgment dated 12.12.2023 disposed of the writ petitions directing the University to extend the affiliation so as to facilitate starting the new course in the next academic year.

The Syndicate at its meeting held on 16.01.2024 considered the matter in the wake of the Judgement of the Hon'ble High Court of Kerala dated 12.12.2023 in WP(C) No. 34243/2023 ,

34303/2023 & 34353/2023 and vide minutes item read as paper 3 above, resolved to renew the affiliation granted vide U.O. No. 7799/AC A1/2023/MGU dated 20.07.2023 so as to facilitate starting the new unaided Law Colleges in the academic year 2024-'25.
