
TENDER DETAILS

Tender form can be had from the **University General Store** on all working days by submitting the E-payment receipt in respect of the tender fee remitted online. (*Tender fee can be remitted online through www.mgu.ac.in - online payment portal - miscellaneous - cost of tender form*)

Tender fee shall be calculated @ rate of 2% of PAC rounded to the nearest multiple of Rs.100/-subject to a minimum of Rs.400/- and maximum of Rs.1500/- + GST @ 12%.





For ensuring the guaranty, terms and conditions, etc. relating to the articles supplied, and Agreement in stamp paper worth Rs.200/- must be submitted by the qualified bidder along with a security deposit @ 5 % of the PAC.
