Earnest Money Deposit (EMD) calculated @ 1% of the Purchase Assessment Cost (PAC), subject to a minimum of Rs. 1500/-, should be paid by the firm. The E.M.D. should be furnished in the form of Demand Draft in favour of The Honorary Director, School of Food Science and Technology, Mahatma Gandhi University payable at State Bank of India, M.G. University Campus Branch, along with sealed tenders.

Tender form and other details can be had from the **University General Store** on all working days, by paying the Tender Fee @ 0.2% of PAC rounded to the nearest multiple of Rs.100, subject to a minimum of Rs. 400/- and maximum of Rs. 1500/- + admissible GST. For ensuring the guarantee, terms and conditions, etc. relating to the articles supplied, a written Agreement must be submitted by the qualified bidder and should submit **5% of the PAC as Security Deposit.**

**Conditions:**

1. The offer should be submitted by the manufacturer/brand or their exclusive agent with certificate of exclusivity from an experienced laboratory furniture/equipment manufacturer.
2. All the modular laboratory furniture shall be designed and manufactured as per International standards and have a registered trade mark/brand name.
3. The Manufacturer/brand shall be an ISO 9001:2015 & ISO 14001-15 & ISO 45001-18 certified. Copy of certification to be attached in the Technical Bid.

4. Manufacturer also should provide their NSIC certificate, MSME registration and Udyog Adhar card with the eligibility submission.
5. The manufacturer should have their service facilities in Kerala and who can attend the site within 24 hrs for the smooth co-ordination and after sales support will be preferred. Confirmation letter to be provided with the bid.
6. Quoted Price should be inclusive of all taxes/freight/loading and unloading/installation/necessary cables for installation etc.
7. Custom / Excise duty exempted price shall be quoted.
8. Quoted rates should have at least six months validity periods.  
Item wise picture/3D of all the items should be included with the technical quotation.
9. The right to accept or reject quotation without assigning any reason rest entirely with undersigned.
10. If the last date of recipient of quotations declared holiday, the next working day shall be the last date for the purpose.
11. Arrangements will be made for bidders to the see room identified on all working days from Monday to Friday between 9.30 am to 4.30 pm.
12. Warranty, AMC conditions, nearest service centre details, supporting catalogue and demonstrations should be provided.
13. Designing/manufacturing/supply and assembly /installation shall be completed within 30 days from issue of award of letter and approvals.
