# AMENDMENT TO THE MAHATMA GANDHI UNIVERSITY STATUTES, 1997

### **AMENDMENT NO. 30**

In exercise of the powers conferred by Section 23 (ii) of the Mahatma Gandhi University Act, 1985, the Syndicate of the University, at its meeting held on 16.01.2024 (item no. 158/24.01/47428/LEGN-2/2023) has resolved to incorporate a new Statute in the Mahatma Gandhi University Statutes, 1997, Statute 3A in Chapter 3, Teachers of the University as follows:


Statute 3A under Chapter 3 - Teachers of the University of Mahatma Gandhi University Statutes 1997 shall be introduced as

3A. The minimum age limit and the maximum age limit for appointment by direct recruitment of teachers in the University shall be the same as that prescribed by the State Government/ respective Statutory body in making appointment to such posts as amended from time to time with the usual relaxation of age limits to eligible communities.

The above Statutes, as amended, read as follows:-

	3A The minimum age limit and the maximum age limit for appointment by direct recruitment of teachers in the University shall be the same as that prescribed by the State Government/ respective Statutory body in making appointment to such posts as amended from time to time with the usual relaxation of age limits to eligible communities.

The above amendment to the Mahatma Gandhi University Statutes, 1997 was assented to by the Hon'ble Chancellor on 20.04.2024 as intimated by the Additional Chief Secretary to the Governor vide letter No. GS5-956/2024 dated 22.04.2024.
