The University has received patents for innovative tyre research that reduces tyre weight and friction with the road and increases fuel efficiency of vehicles, as part of nanotechnology research conducted with Inha University in South Korea, a capacitive temperature sensor made of nanocomposites with polyvinyl chloride and carbon nanotubes, and a discovery of increasing the electrical transmission resistance of polymer compounds used for insulation purposes.

This significant discovery has been made in the tyre industry through the research conducted by chemical science researchers at MG University, V. Prajitha and K.P. Jibin, supervised by Prof. Sabu Thomas and Prof. Nandakumar Kalarikkal.

The sensors capable of controlling temperatures ranging from 10 degrees Celsius to 50 degrees Celsius, have been developed as part of Dr. Elizabeth Francis's PhD research. Her research was started under Prof. Dr. Sabu Thomas and President of Conclavit, Bengaluru's educational platform.

Prof. Dr. Sabu Thomas of the Joseph Stefan Institute in Slovenia. Euros Svelber, Dr. Miren Mozetic, Dr. P. In a study conducted by Harinarayanan and others, the discovery of increasing the electrical transmission resistance of polymer compounds used for insulation purposes was made.

The significant finding on increasing the electrical transmission resistance of polymer compounds used for insulation purposes is part of the study conducted by Prof. Dr. Sabu Thomas, Dr. Euros Svelber, Joseph Stefan Institute in Slovenia, Dr. Miran Mozetic and Dr. P. Harinarayanan. This study could have considerable implications for industries relying on such materials, potentially improving the efficiency and safety of electrical systems. Kudos to Prof. Sabu Thomas and other researchers.

For maintaining the second position in the list of material science scientists in India in the third ranking of Research.com, Prof. Sabu Thomas is felicitated by the Academic Council of the University.
