**ORDER**

The University has issued 'The Mahatma Gandhi University Youth Festival Rules, 2024' vide paper read (1) above. Subsequently, amendments were made to these rules, vide paper read (2), (3), (4) and (5) above.

Now, based on the request submitted by the Director of the Department of Student Services, the Syndicate has resolved to include Debate, Rangoli and Mehndi- items featured in the South Zone/National level Arts Festival organised by the Association of Indian Universities, in the Mahatma Gandhi University Inter-Collegiate Youth Festival. It has also been decided to include D.S.S Programme Coordinators as members of the Steering-cum-Appellate Committee (SAC) formed for organising the Youth Festival in Affiliated Colleges, vide paper read (6) above.

Accordingly, the following items will be included in the Mahatma Gandhi University Inter-Collegiate Youth Festival:

- **Debate English (Schedule I-III Literary Event)**
- **Debate Malayalam ( Schedule I-III Literary Event)**
- **Mehndi (Schedule I-V Theatre Event)**
- **Rangoli (Schedule I-V Theatre Event)**
