ORDER

As per the U.O read as Paper (1) above, provisional affiliation was granted to the Co-operative School of Law, Vengalloor, Thodupuzha for conducting Three Year Unitary LL.B and Five Year Integrated B.A LL.B(Hons) programmes subject to the receipt of NOC from the Government of Kerala and approval from the Bar Council of India, for the Academic year 2024 - '25. Consequently, the College approached the Bar Council of India (BCI) for approval. The BCI vide its letter read as (2) above, granted fresh approval of affiliation to Co-operative School of Law, Vengalloor, Thodupuzha, Idukki, Kerala for imparting Three Year Unitary LL.B and Five Year Integrated B A LL.B(Hons) programmes with an intake of one section of 60 students in each programme, for the Academic year 2024-2025.

The Government of Kerala, vide its orders read as Papers (3) & (4) above, accorded Administrative Sanction and issued No Objection Certificate respectively to Co-operative School of Law, Vengalloor, Thodupuzha for conducting Three Year Unitary LL.B and Five Year Integrated B.A LL.B(Hons) programmes for the Academic year 2024-'25.

The Syndicate at its meeting held on 21.02.2025 considered the matter in the light of the aforementioned documents and, vide Minutes read as Paper (5) above, resolved to grant provisional affiliation to the Three year Unitary LL.B and Five Year Integrated B A LL.B(Hons) programmes in the Co-operative School of Law, Vengalloor, Thodupuzha, for the Academic year 2024-'25 as detailed below:

The provisional affiliation granted is subject to the following conditions:

- 1. The provisional affiliation granted is for the academic year 2024-'25 only.
- 2. The programme shall be conducted as per the approved scheme and syllabus.
- The admission of the students and commencement of classes for the said programme in the College shall be in accordance with the rules and regulations of the University and Bar Council of India.
- 4. The Educational Agency shall furnish an undertaking in stamp paper with a face value of Rs 200/- to the effect that it will abide by the rules, regulations and instructions issued by the University, State Govt. and Bar Council of India regarding the admissions to the programmes from time to time.
- 5. The institution shall observe the admission norms regarding the eligibility of candidates and the norms of reservation framed by the Government, Commissioner of Entrance Examinations, University and Bar Council of India.
- 6. The College has to remit an amount of Rs.48,625/- +18% GST towards course affiliation fee (initial affiliation) for each programme.
- 7. The Educational Agency shall set apart 50% of the seats of the Courses for being filled up by the Govt or such authority determined by the Government and remaining 50% filled by the Educational Agency on the basis of merit provided they satisfy the eligibility conditions prescribed by the University.

- b) Students Insurance Premium Rs.23/- per student per year
- c) Students welfare fund Rs.45/- per student per year
- d) University Union Fees Rs.65/- per student per year
- e) Sports Affiliation Fee due to the University Rs.255/- per student per year
- f) The collection of annual administration fee from the students under any circumstances is not permitted.
- g) Student's Affiliation fee Rs. 1260/- collected on one time basis from all students shall be remitted to the University within 15 days after closing admission.
- 9. The College shall submit the list of students admitted and remit the fees due to University within 15 days after closing the admission.
- 10. There shall not be any financial commitment to the Govt/University.
- 11. Non-compliance with any of the above mentioned conditions will result in the withdrawal of the provisional affiliation without any notice.
