ORDER

As per reference cited (1) , Dr. Nandakumar Kalarikkal had been awarded with IFCPAR/CEFIPRA (Indo French Centre for the Promotion of Advanced Research) Project entitled "Bio-filler-Interfaced Electrospun PVDF-Nanomultiferroic Hybrid Piezoelectric Generator for Mechanical Energy Harvesting" with a total project fund of 59,79,752/- (Rupees Fifty Nine Lakh Seventy Nine Thousand Seven Hundred and Fifty Two Only).The first, second and third year grants had already been released to the account opened for the project as per reference cited (3), (4) and (5) above.

As per reference cited (6) , the IFCPAR/CEFIPRA has sanctioned Rs. 3,37,143/- (Rupees Three Lakh Thirty Seven Thousand One Hundred and Forty Three Only) towards the grant for meeting the international travel expenses of the Principal Investigator. The released amount had been credited to the University account and entry No.11141 dated 29.01.2025 been made in the RR accordingly.

The Principal Investigator, vide reference cited (7), has requested to transfer the amount cited to the account opened for the Project.The Finance wing has recommended to release the travel grant of Rs. 3,37,143/- (Rupees Three Lakh Thirty Seven Thousand One Hundred and Forty

Three Only) to the savings bank account opened for the project.

In the above circumstances, sanction has been accorded by the Vice Chancellor to release Rs. 3,37,143/- (Rupees Three Lakh Thirty Seven Thousand One Hundred and Forty Three Only) towards the grant for meeting the international travel expenses of the Principal Investigator, Dr.Nandakumar Kalarikkal, in connection with IFCPAR/CEFIPRA project entitled "Bio-filler-Interfaced Electrospun PVDF-Nanomultiferroic Hybrid Piezoelectric Generator for Mechanical Energy Harvesting" to the account opened for the project (Account No: **40144791283**, Account Name : **CEFIPRA PROJECT by Dr. Nandakumar**, SBI M.G University Campus Branch).
