ORDER

The existing eligibility criteria for admission to the Bachelor in Computer Applications (Honours) programme in affiliated arts and science colleges are, 'Candidates shall be required to have passed the Plus Two / equivalent examination with Computer Science / Mathematics / Statistics / Accountancy / Informatics Practices as one of the optional subjects.'

In light of the emerging need to include specializations in Accountancy offered by various Boards, the Expert Committee on Computer Applications (UG), discussed the need to modify the eligibility criteria for admission to the Bachelor in Computer Applications (Honours) programme and has submitted the following recommendation vide paper read as (1) above.

"Candidates shall be required to have passed the Plus Two / equivalent examination with Computer Science / Mathematics / Statistics / Accountancy / Accountancy with AFS / Accountancy with Computer Accounting / Accountancy with Computer Science / Informatics Practices as one of the optional subjects."

Considering the urgency of the matter, sanction has been accorded by the Vice Chancellor, in exercise of the powers of the Academic Council vested upon him under Section 10(17), Chapter III of the Mahatma Gandhi University Act 1985, vide paper read as (2) above, to approve the aforementioned recommendation.

Hence, the eligibility criteria for admission to the Bachelor in Computer Applications (Honours) programme in affiliated arts and science colleges, stands modified to this extent.
