<u>ORDER</u>

The Principal, Bharata Mata School of Legal Studies, Choondy, Aluva vide the Paper read as (1) above, had submitted an application to start a Three Year Unitary LL.B programme (60 seats) for the Academic year 2025-'26.

The Inspection Commission constituted vide the University Order read as Paper (2) above, assessed the infrastructural and instructional facilities available at the College and submitted its report.

The Syndicate at its meeting held on 26.03.2025, considered the report submitted by the Inspection Commission vide Item read as Paper (3) above, and resolved to grant provisional approval to start Three Year Unitary LL.B programme at Bharata Mata School of Legal Studies, Choondy, Aluva. This is subject to the implementation of the recommendation of the Inspection commission to obtain an affidavit from the College authorities stating that the infrastructural and instructional facilities will be arranged prior to the commencement of the programme, and further subject to the receipt of Administrative Sanction & NOC from the Government of Kerala, as well as the approval of the Bar Council of India.

The details of the programme approved for the Academic year 2025-26 are as follows

The provisional approval granted is subject to the following conditions:

1. The provisional approval granted for the Academic year 2025-'26 is only for seeking views/NOC from the Government of Kerala and approval of the Bar Council of India.

2. The starting of the above programme shall be done only after obtaining the NOC from the Government of Kerala and approval of the Bar Council of India.

3. The admission of Students and the commencement of classes for the said programme in the College shall be in accordance with the rules and regulations of the University and Bar Council of India.

4. The Educational Agency shall furnish an undertaking on a stamp paper with a face value of Rs 200/- to the effect that it will abide by the rules, regulations and instructions issued by the University, State Govt. and Bar Council of India regarding the admissions to the programme from time to time.

5. Further instructions in this regard relating to admission notification, fee structure and other admission rules shall be issued on production of the NOC from Government of Kerala and approval from the Bar Council of India.

6. There shall not be any financial commitment to the Govt/University.

7. Non-compliance with any of the above mentioned conditions will result in the withdrawal of the provisional approval without prior notice.

Orders are issued accordingly.
