ORDER

The Government of Kerala, vide Paper read as (1) above, granted approval for the Campus Industrial Park Scheme- 2024, permitting the transfer of unused land under the control of educational institutions functioning under the Higher Education Department, for industrial development. The scheme aims to establish Campus Industrial Parks on such lands, thereby fostering entrepreneurial skills among students.

The Principal (i/c), Sree Sabareesa College, Murukkumvayal vide Paper read as (3) above, submitted an application seeking a recommendation for obtaining No Objection Certificate (NOC) from the Higher Education Department for establishing a Campus Industrial Park on the college campus.

The Syndicate at its meeting held on 26.03.2025, considered the matter and vide the Paper read as (3) above, resolved to appoint Dr. A. S Sumesh, Member Syndicate, as Inspection commission to assess the facilities available at the college for the establishment of Campus Industrial Park.

The College is directed to contact the member of Inspection Commission to schedule the date of inspection and remit an amount of Rs.5145/- towards inspection fee.

The Inspection Commission shall conduct inspection and submit a report with specific recommendations in the prescribed format to the Registrar at the earliest.
