ORDER

The Director of Collegiate Education, Government of Kerala vide Paper read as (1) above, submitted an application for starting a new Arts & Science college named "Kesari Memorial Government Arts and Science College" at North Paravur, commencing from the Academic year 2025-'26.

An Inspection committee was constituted, vide U.O read as (2) above to assess the instructional and infrastructural facilities available for the establishment of the new College. Following a thorough inspection of the physical infrastructure and primary needs for the new college, the Inspection committee put forth the below mentioned recommendations.

1. The existing Building has to be properly rewired and provided with sufficient ceiling to create a clean and modern technological ambience needed for the current educational institutions
2. The library has to be upgraded with books recommended by the Subject Experts in their separate reports. In future the college has to enroll in the list of 'One nation One Subscription' portal so that all updated access shall be made available for electronic journals, books and articles.
3. Immediate steps should be taken to provide a computer lab with at least 20 computers before the commencement of the classes.
4. The college should take immediate initiative to get the appointment of 15 faculty members and 14 non-teaching staff, out of which 10 faculty members and 5 non teaching staff are already under process of appointment.

The Government of Kerala, vide the Paper read as (3) above, granted approval to start the New Government Arts & Science College during the Academic Year 2025-'26 under the name ' Kesari Government Arts & Science College, North Paravur, Ernakulam ' with the change limited to the name from the earlier proposal.

The Syndicate, vide the Paper read as (4) above, considered the matter and, recommended to grant provisional affiliation to Kesari Government Arts & Science college based on the approval granted by the Government of Kerala vide G.O read as Paper (3) above, for the programmes listed below. This is also subject to the condition that the requirements mentioned in the report of the duly appointed Inspection committee regarding establishment of the college shall be fulfilled within one year, upon obtaining an affidavit to that effect from the Director of collegiate Education .

The Provisional affiliation granted is subject to the following conditions:

1. The Provisional affiliation granted initially for a period of one Academic year only (2025-2026).
2. The College shall prepare and present the Students in accordance with the Laws of the University for the examination and as per the approved Scheme and syllabus of the University in the subjects concerned.
3. The details of various items of fees related to the programme are given below:
 - a) Students Safety Insurance - Rs.100/- per student per year
 - b) Students Welfare Fund - Rs.50/- per student per year
 - c) University Union Fees - Rs.70/- per student per year
 - d) Sports Affiliation Fee due to the University - Rs.270/- per student per year
 - e) Student's Affiliation fee - Rs. 775/- (for UG Programmes) collected on one time basis from all students shall be remitted to the University within 15 days after closing admission.
4. The rate of Tuition fee is as per Government orders issued from time to time.
5. Rs. 1,27,635/-(Rupees One Lakh Twenty Seven Thousand Six Hundred and Thirty Five Only) shall be remitted to Mahatma Gandhi University Fund towards Initial Affiliation Fee for new college and also remit Rs.12,770/-(Rupees Twelve Thousand Seven Hundred and Seventy Only) as Initial Course Affiliation Fees for each Programme.

6. The College shall submit the list of Students admitted and remit the fees due to University within 15 days after closing of admission.
7. There shall not be any financial commitment to the Govt/University.
8. The affiliation granted is subject to the clauses in Mahatma Gandhi University Act , 1985 & Statutes 1997.
9. The admissions to the programmes shall be in accordance with the Merit/ Reservation norms and conditions of Government/ University from time to time.
10. The College shall maintain a website and publish the details regarding admission, fees, programmes, results, Teaching and Non teaching staff, grievance redressal mechanism for the Students and any other information as required by the Government and the University.
11. The College shall run only programmes approved by the Government and the University.
12. The College shall not combine the programmes for which the affiliation is granted by the University with any other add on programmes.
13. The College shall agree to enable the University and its representative to check, verify and monitor the compliance of the conditions mentioned above at any time the University so decides.
14. The College shall prepare and submit a Demand Collection Balance Statement for the year preceding the academic year for which the affiliation is granted and remit all fees and revenue due to the University including the refund from the Government in terms of e-grants.
15. The College shall collect fees from students fixed by the University from time to time and duly remit to University.
16. The programmes shall be conducted in accordance with the Scheme and Syllabus approved by the University. The Principal shall admit students only to sanctioned strength of approved Programmes.
17. The College shall abide by the conditions put forth by them in the affidavits submitted.
18. There shall be no financial commitment to the University for the proposed courses.
19. The College shall seek NAAC accreditation for the institution at the earliest.
20. Non-compliance with any of the above mentioned conditions will result in the withdrawal of the Provisional affiliation granted to the College without any prior notice.

Orders are issued accordingly.
