#### **ORDER**

As per paper read as (1) above, The Indian Council of Social Science Research (ICSSR) had selected Dr. John M S, for the award of Senior Fellowship to work on research theme entitled "Patterns of Political Violence and Prospects for Peace in North Malabar" w.e.f 20.12.2022. The first and second instalments of the fellowship sanctioned by ICSSR had already been released as per references cited (2) & (3) above.

As per paper read as (4) above, the ICSSR had sanctioned Rs. 2,90,000/- (Rupees Two Lakh Ninety Thousand Only) towards the first instalment of second year fellowship to Dr. John M S. The amount was credited to University Account (A/c No. 38492884430) and the PFMS Section confirmed the same.

The Finance wing of University has recommended to release the first instalment of second year fellowship grant to Dr. John M S to his account after deducting the TDS. The break up details are as follows:-
